Living with cancer, half a heart and a myriad of other challenges, soft-spoken 14-year-old Erik has always wanted to jump, run, and help others. When given the chance to make a wish, Erik didn't skip a beat; "I wish to be a superhero."

It all began for Erik the morning he received a call from Spiderman. Only Erik, otherwise known as "Electron Boy," could prevent his nemeses "Dr. Dark" and "Blackout

Boy" from robbing the city of light and imprisoning innocent civilians. Electron Boy and his sidekick "Lightning Lad" jumped in his Back to the Future inspired DeLorean and raced to the city with the help of the Bellevue Motorcade, which stretched a mile long and shut down major highways.

One hero can do it all for this city. From freeing the city's professional soccer team (the Seattle Sounders)

It seems like ages ago that four-year-old Brooke wished to go to Disney World® to meet the princesses. Because Brooke is battling an immunodeficiency disease, eight years of medical complications prevented her from her dream vacation.

At last, 12-year-old Brooke was finally ready to leave the hospitals behind when she was told she could pack her bags, because her long-awaited wish trip was only a plane ride away.

Brooke and her family packed their sunscreen and hopped on a plane to Disney World for a family getaway in the sunshine. According to her mom, Haidee, the trip was a much-needed respite for Brooke and her brothers.

Brooke was excited for weeks before her trip. By the time they had their send-off party at Red Robin, where she was treated like royalty, she already knew it would be well worth the wait.

Together, Brooke and her family tackled every ride they could, and some more than once. They kept their days busy from dawn until dusk meeting princess after princess. She also made quite a few new friends including Sponge Bob, Dora the Explorer, Homer Simpson, Wolverine, and Green Lantern. "She was so excited, she was hugging everyone," Haidee said. "She would just go up to every character she saw and hug them!"

Months later, Brooke still recalls her special week with celebrity status in

Disney World. "She's always talking about it," said her mom.

Brooke's younger brother, Matthew, is battling the same immunodeficiency syndrome as his sister and is now awaiting his referral for a wish. He plans to follow in his big sister's footsteps, and take their family right back to Disney World.

"He's excited," she said. "Next time he'll be tall enough to ride all the rides, too."



YO-HO A PIRATE'S LIFE FOR ME

Joseph lives in a world of tall ships, buried treasure, and loaded cannons ready to fire. It was no surprise to anyone when Joseph wished to be a pirate for a day! Being a pirate takes a lot of bravery, and this 13-year-old, who is battling a life-threatening heart condition, proved to be the most courageous buccaneer of any boisterous crew on the high seas.

In preparation for his wish day, Joseph found a treasure map on his doorstep every full moon for five months. Joseph was also made the guest of honor at the *Pirates of Penzance* theater production in his hometown in Eastern Washington.

Joseph's wish weekend began at his hotel room in downtown Seattle during the annual Seattle Seafair celebration. The Seafair Pirates knocked on Joseph's door, asking for his help to defeat the soldiers who had stolen the Seafair treasure and buried it at Alki Beach in West Seattle. So, Joseph donned his pirate swag and climbed aboard the infamous "Moby Duck" as the police escorted him and the wild bunch to West Seattle.

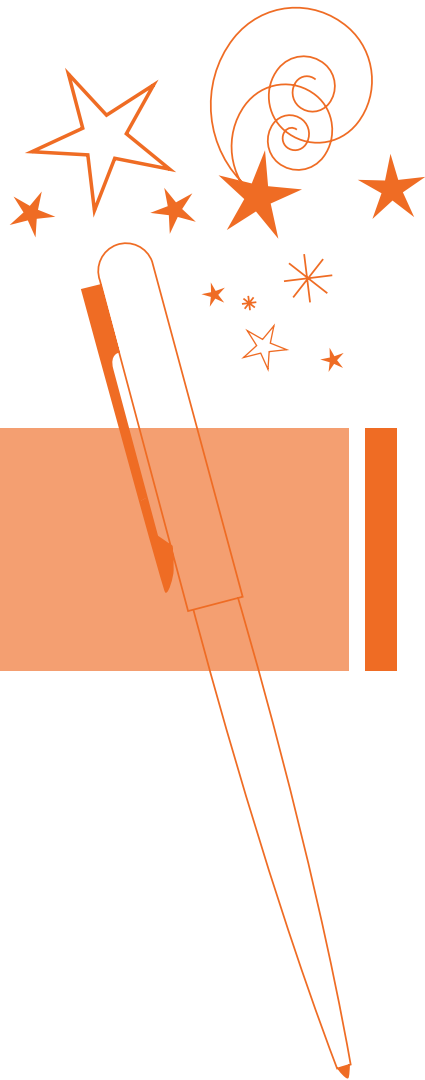

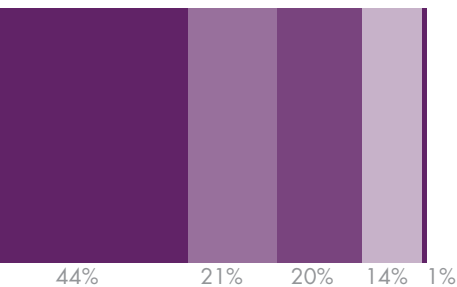

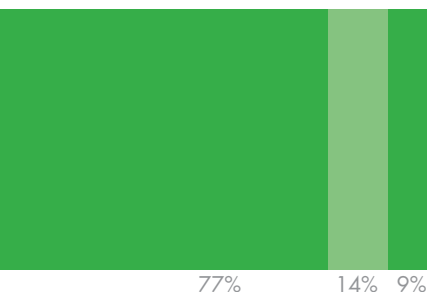
FUNDRAISING

We are grateful for the dedicated and generous support from thousands of community members, businesses, corporations, foundations, clubs and associations. Contributions and investment income received by the Make-A-Wish Foundation of Alaska, Montana, Northern Idaho and Washington* during the 2010 fiscal year (September 1, 2009 to August 31, 2010) totaled \$5,015,112. Included in this amount are in-kind contributions totaling \$2,340,523. Net assets at the end of the year totaled \$2,579,535. Of every dollar spent in the fiscal year 2010, 77 cents went directly to expenses granting wishes for children with life-threatening medical conditions.

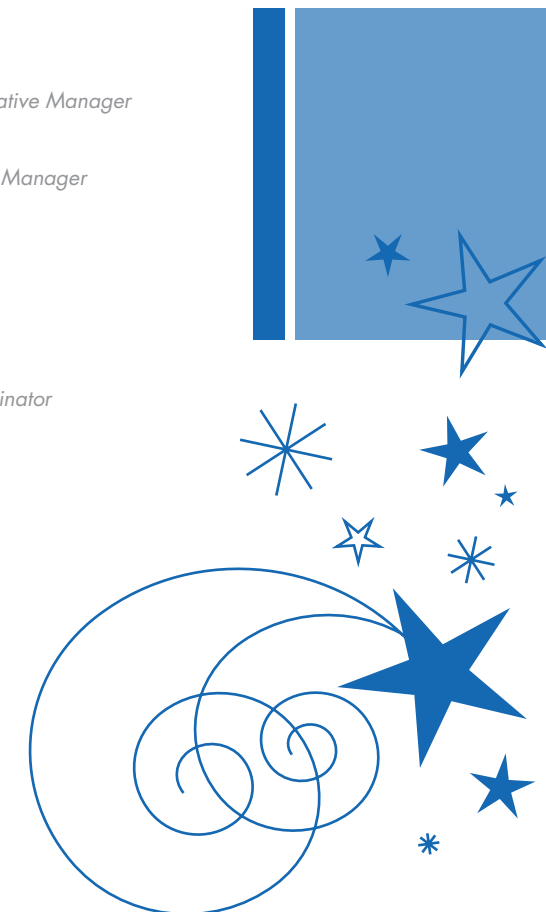
